## **Town Manager's Report**

## **MARCH 2011**

#### Streets:

- Staff repaired a few fire hydrants around town.
- Staff repaired a number of street lights.
- Staff cleaned East and West Main Streets.
- Staff took part in a customer service training program.

#### Water:

- Rainbow Lake is flowing over the spillway level.
- The roughing filters are being backwashed twice per day and the DE filters are being done once per week.
- Staff replaced the check valve on Well No. 2.
- Our wells appear to have recovered and the water levels are now within one foot of the May 2010 levels.
- Water production and consumption. We produced and purchased an average of 289,609 GPD. We consumed an average of 256,997 GPD.

The difference is "Backwash Water" ... (11.3%). We purchased 347,000 gallons of water from MSM this month.

- o 39.0% of this water came from wells.
- o 3.9% of this water came from Mt. St. Mary's.
- o 57.1% of this water came from Rainbow Lake.

#### Wastewater:

- The overland flow treatment system is up and running for the season.
- Staff replaced a skimmer pump in the contact tank at the wastewater treatment plant.
- We received about 6.7 inches of precipitation this month (the average is 3.9 inches).
  - We have a precipitation **DEFICIT** of 4.5" over the last six months. The average precipitation for the period from October 1 thru March 31 is 21.2". We have received 16.7" for that period.
- Wastewater Treatment:
  - We treated an average of 818,000 GPD (consumed 256,997 GPD) which means that 68.6% of the wastewater treated this month was "wild water".
  - We had a spill of 12,000 gallons of untreated sewerage on March 10. It happened at MH-98 in Emmit Gardens.

 We did exceed the plant's design capacity seven (7) days during the month of March:
